

快易通宣布退出儲值支付工具業務

(2025 年 12 月 15 日 下午 2 時 | 香港) 快易通有限公司 (下稱「快易通」) 現時為「易通行」隧道費服務商。自「易通行」於 2025 年 5 月起已於全港所有政府收費隧道及青沙管制區實施，相關隧道及管制區的快易通電子道路收費系統 (下稱「ETC」) 已停止營運。因此，本公司將會於 2026 年 3 月 16 日退出儲值支付工具業務，並終止快易通 ETC 及 VGoPAY 電子錢包服務。

現時透過快易通 ETC 或 VGoPAY 繳付「易通行」隧道費及港珠澳大橋通行費之客戶，應盡快轉用其他自動付款方式。如戶口內尚有餘額，請參照下列說明以取消戶口及申請退款；而沒有餘額的戶口則於 2026 年 3 月 16 日自動取消，客戶無需採取任何行動。若閣下同時持有快易通 ETC 及 VGoPAY 戶口，應分別進行取消手續。

1. 條款及細則

本條款及細則自 2026 年 1 月 15 日起對所有客戶生效。

2. 簡介

所有快易通 ETC 及 VGoPAY 服務將於 2026 年 3 月 16 日全面終止。Autotoll Club 網站、VGo 及 VGoPAY 手機應用程式將於 2026 年 3 月 16 日凌晨 0 時停止運作。屆時，用戶將無法登入 Autotoll Club 網站、VGo 或 VGoPAY 手機應用程式進行交易。

2026 年 3 月 16 日至 2026 年 5 月 15 日期間（「凍結期間」），為進行儲值支付工具業務退出審計工作及執行相關程序，收到的快易通 ETC 及 VGoPAY 取消戶口申請的退款流程將暫時中止。2026 年 5 月 16 日至 2026 年 11 月 15 日期間（「贖回期間」），快易通 ETC 及 / 或 VGoPAY 戶口餘額的贖回手續將依照以下條款及細則執行。

3. 贖回申請

4. 信託管理費

2026 年 5 月 16 日起，快易通 ETC 及 / 或 VGoPAY 戶口中的餘額將被扣減相應的每月信託管理費，餘額將分為六份每月攤銷。首兩個月（即 2026 年 6 月 15 日及 2026 年 7 月 15 日）將扣減每月 10% 信託管理費；第三至第六個月（即 2026 年 8 月 15 日、2026 年 9 月 15 日、2026 年 10 月 15 日及 2026 年 11 月 15 日）將扣減每月 20% 信託管理費。

5. 豁免申請

Autotoll Announces Exit from Stored Value Facilities (“SVF”) Businesses

(Hong Kong - 15 December 2025 2:00 PM) Autotoll Limited (“Autotoll”) now serves as the “HKeToll” Toll Service Provider. Since the implementation of HKeToll at all Government tolled tunnels and the Tsing Sha Control Area in Hong Kong in May 2025, Autotoll’s Electronic Toll Collection (“ETC”) system has ceased to operate at these tunnels and control area. Therefore, Autotoll will exit the SVF business and terminate the Autotoll ETC and VGoPAY services on 16 March 2026.

Customers currently using Autotoll ETC and/or VGoPAY to settle HKeToll and Hong Kong-Zhuhai-Macao Bridge (“HZMB”) tolls should promptly set up an alternative auto-payment method. Additionally, if you have remaining balances in your Autotoll ETC and/or VGoPAY accounts, you can arrange account cancellation and apply for the refund of balance through the methods below. No action is required if you do not have a remaining balance, your account will be closed automatically on 16 March 2026. If you hold both Autotoll ETC and VGoPAY accounts, cancellation should be arranged separately for each account.

Alternative Payment Means

Customers paying HKeToll’s toll using Autotoll



Please set up your HKeToll account with auto payment to settle tunnel tolls **before 16 March 2026**.

- **If you have already signed up for an HKeToll account:** Please log into your HKeToll account and follow the on-screen instructions to set up a Designated Stored Value Account (“DSVA”) with **auto top-up** via HKeToll mobile app or website (HKeToll.gov.hk). The DSVA supports auto top up using credit card or direct debit via a bank account. If you have forgotten your login name, please click [here](#) to reset it. If you have forgotten your login password, please click [here](#) to reset it.
- **If you have not yet signed up for an HKeToll account:** Please download the “HKeToll” mobile app or click [here](#) to sign up for an HKeToll account. Please follow the on-screen instructions to associate your vehicle to your account and sign up for a DSVA with auto top-up. The DSVA supports auto top up using credit card or direct debit via a bank account.
- After the termination of Autotoll ETC and VGoPAY services, you can no longer use your Autotoll account for automatic payment of tolls. If you have not set up a new auto payment means, you must pay the toll within 14 business days after passing through the tunnel in accordance with the law. **Please note that a surcharge of up to HK\$525 per trip will be imposed for any late payments, and your application for vehicle licence renewal or transfer of vehicle ownership may be refused.**

Arrangements After Termination of Services

Customers who have not submitted notices of cancellation of accounts and with leftover balances will incur Trust Management Fees starting from 16 May 2026, as outlined in the “[Autotoll ETC and VGoPAY Account Redemption Terms and Conditions](#)” which will come into effect on 15 January 2026. We will engage an independent 3rd party custodian agency to oversee the redemption.

Customers submitting redemption applications from 16 May 2026 will be reimbursed the remaining balance (after deducting Trust Management Fees) via bank transfer within 30 working days after processing. To avoid further fees, please submit a redemption form via our dedicated website for redemption of the leftover balance before 16 May 2026.

Autotoll ETC and VGoPAY Account Redemption Terms and Conditions

1. Terms and Conditions

These Terms and Conditions ("T&Cs") are effective from 15 January 2026 for all customers.

2. Introduction

All Autotoll ETC and VGoPAY services will terminate on 16 March 2026. The Autotoll Club website, VGo and VGoPAY mobile applications will be retired on 16 March 2026 at 0:00 AM. After this time, you will no longer be able to login to the Autotoll Club website, VGo or VGoPAY mobile applications to conduct transactions.

Between 16 March 2026 and 15 May 2026, the refund process for Autotoll ETC and VGoPAY account cancellation applications received will be frozen ("Frozen Period") for Stored Value Facilities business exit audit and execution of relevant procedures. Between 16 May 2026 and 15 November 2026, the redemption of leftover balances in Autotoll ETC and/or VGoPAY accounts will be executed according to the T&Cs below ("Redemption Period").

3. Redemption Request

To redeem the leftover balance in Autotoll ETC and/or VGoPAY account, customers may visit our redemption website and submit the "Notice of Cancellation of Autotoll Account" and/or "Notice of Cancellation of VGoPAY Account" via the website as follows:

For redemption requests that are received during the "Frozen Period", the leftover balance will be disbursed after 15 May 2026, which are not subject to any Trust Management Fees mentioned in Clause 4 below.

For redemption requests that are received during the "Redemption Period", after deduction of Trust Management Fees, the leftover balance will be disbursed within 30 working days.

4. Trust Management Fees

Starting from 16 May 2026, monthly Trust Management Fees will be charged against the remaining leftover balance in the Autotoll ETC and/or VGoPAY account, which will be divided into six parts and amortised every month. A 10% monthly Trust Management Fees will be applied in the first and second month. (i.e. 15 June 2026 and 15 July 2026). A 20% monthly Trust Management Fees will be applied in the third, fourth, fifth and sixth month (i.e. 15 August 2026, 15 September 2026, 15 October 2026 and 15 November 2026).

For example, the remaining balance of HK\$100 at the beginning of the "Redemption Period" on 16 May 2026 ("Starting Balance") will have the Trust Management Fees deducted according to the table below:
